COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Moncks Corner woman on contraband and drug charges involving a visit at MacDougall Correctional Institution.

Marqui Cimone Cooper, 30, is charged with distribution of methamphetamines, possession of marijuana with intent to distribute, providing contraband to an inmate and criminal conspiracy. The charges involve smuggling drugs into the visitation room at MacDougall and giving them to an inmate.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
