COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrant today for a correctional officer at Kershaw Correctional Institution.

Kionna Rakayla Grant, 28, of Garnett, is charged with misconduct in office. Her charge involves having a personal relationship with an inmate, allowing him to have a contraband phone and accepting/sending money through a cash application. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
