COLUMBIA, S.C. – The SCDC Inspector General released arrest warrants today for a correctional officer at Lee Correctional Institution.

Britney K. Felder, 31, of Clarendon County, is charged with possession of drugs with intent to distribute, criminal conspiracy and misconduct in office. The charges involve packages of wrapped contraband containing cigars, loose tobacco, lighters, rolling papers and 581 grams of synthetic marijuana, commonly known as K-2. The contraband was discovered by the SCDC Inspector General's K-9 drug unit. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Facts to prove the same are as follows: The Defendant is a sworn Correctional Officer with South Carolina Department of Corrections. While at LeeCI, a South Carolina Department of Corrections Office of Inspector General narcotics K-9 alerted on Felder and her vehicle during a routine K-9 operation. During a search of Felder's vehicle, approximately 581 grams of synthetic marijuana was found in the trunk of her vehicle. Probable Cause is based on the investigation and recovery of evidence.

Britney K. Felder did violate Section 24-3-950 of the South Carolina Code of Laws, Furnishing or Attempting to Furnish Prisoners
with contraband. Facts to prove the same are as follows: The Defendant is a sworn Correctional Officer with South Carolina
Department of Corrections. While at LeeCI, a South Carolina Department of Corrections Office of Inspector General narcotics K-9
alerted on Felder and her vehicle during a routine K-9 operation. During a search of Felder's vehicle, 15 Filtered Cigars, 4 cigarette
lighters, 13 boxes of tops rolling papers, 57 field weighted grams of loose tobacco, as well as scented rolling papers were all found
inside one package sealed in such a way which is consistent throughout South Carolina with the introduction of contraband to
inmates in the South Carolina Department of Corrections.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On February 23, at Lee Correctional Institution located at 990 Wisacky Hwy, Bishopville SC 29010, in the county of Lee, the defendant, Britany K. Felder, an employee with the South Carolina Department of Corrections, was found to be in possession of 4 tightly sealed rolls of green leafy plant like material (GPM). 4 rolls were recovered during a lawful search of her vehicle, a 2018 Chevy Malibu, after a South Carolina Department of Corrections (SCDC) Office of Inspector General (OIG) narcotics K-9 alerted on the vehicle, which felder admitted was her vehicle. The rolls were recovered from inside of the vehicle's trunk. The GPM field tested presumptive positive for Synthetic Marijuana with a total field weight of 581grams. Probable cause is based on the investigation, and recovery of evidence.
