**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a correctional officer at McCormick Correctional Institution.

Angel Monique Butler, 23, of Hephzibah, Ga., is charged with failure to report sexual misconduct and misconduct in office. The charges involve failing to report a sexual relationship between a fellow officer and an inmate. Officers are required by law to report any sexual misconduct to authorities. She was fired.

Last month, former officer Jaiona Zyrelle Finney was fired after being charged with having a sexual relationship with an inmate at McCormick.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
