**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrant today for a Columbia woman on charges of misconduct in office while employed as a correctional officer.

Makesha Fair, 46, is charged with misconduct in office involving an incident that took place March 10, 2022, at Gilliam Psychiatric Hospital within Kirkland Correctional Institution in Columbia.

Fair's charges include falsifying a report to conceal the assault of an incarcerated inmate, falsely reporting the events, omitting her actions from the report, giving verbal direction to other correctional officers who witnessed the assault to omit details in their reports and withholding video evidence of the assault. Probable cause is based on victim and witness statements, written reports and video evidence. She resigned before the investigation was complete.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
