**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for four Upstate women on charges involving contraband at Broad River and Lieber correctional institutions.

The charges:

- Amy Michelle Johnson, 50, of Lyman: providing contraband to prisoners, criminal conspiracy, possession of a controlled substance and possession of a firearm by someone convicted of a felony.
- Kayla Diana Jackson-Fulmer, 37, of Greenville: providing contraband to prisoners and criminal conspiracy.
- Haley Renae Alexander, 24, of Greer: providing contraband to prisoners and criminal conspiracy.
- Wanda Ann Alexander, 44, of Lyman: possession of a controlled substance and possession of a firearm by someone convicted of a felony.

The charges allege a conspiracy with the women and multiple inmates involving contraband disguised as legal mail. The confiscated packages contained substances that tested positive for marijuana, methamphetamines, tobacco, blunt wrappers, and several pages coated with an unknown substance.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Alexander did coordinate with at least two other individuals in order to deliver a contraband package disguised as legal mail to several inmates within the SCDC, including an inmate incarcerated at Broad River CI, & Lieber CI, The packages were discovered during a search of inmate mail and contained a substance that did field test presumptive positive for marijuana, a substance that did field test presumptive positive for methamphetamine, tobacco, dozens of "blunt" wrappers, and several pages coated in an unknown substance, these items are considered contraband by the Director of the SCDC. Search warrants were executed on two cell phones belonging to a co-defendant that contained several messages between Alexander & multiple parties, including inmates, coordinating the packaging & delivery of contraband.
