COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrant today for a former correctional officer at Turbeville Correctional Institution.

Arieyelle Shiquise Coulette, 25, of Sumter, is charged with misconduct in office. Charges against her involve receiving more than \$22,000 from inmates and sending more than \$6,700 to inmates through cash apps.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

From on or about August 23, 2021, to September 27, 2021, the defendant Arieyelle Coulette, a Certified Correctional Officer formerly employed with the South Carolina Department of Corrections who resigned on November 17, 2023, did willfully, knowingly, dishonestly, and unlawfully with malfeasance commit the offense of Misconduct in Office by accepting approximately \$22,879 from incarcerated SCDC inmates via Cash App. Coulette also sent approximately \$6,790 to incarcerated SCDC inmates. During this time, Coulette was employed by SCDC at Turbeville Correctional Institution, located at 1578 Clarence Coker Hwy, Turbeville, SC 29162, which is located in the County of Clarendon, SC. Probable cause is based on the evidence derived from the investigation.
