COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrant today for a former nurse at Broad River Correctional Institution.

Janet Marie Hawkins, 61, of Cayce, is charged with theft of a controlled substance. The charge against her involves stealing 40 Hydrocodone pills and at least one Tylenol codeine pill. She resigned before the investigation was completed.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

The arrest warrant is attached.
