COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Greenwood woman on charges involving contraband at Lee Correctional Institution.

Miangel Jaycee Clark, 29, is charged with providing contraband to an inmate and criminal conspiracy.

Clark's charges involve passing two packages of a substance believed to be marijuana to an inmate during visitation Dec. 22. She was arrested outside her home in Greenwood yesterday.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
