**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for 11 inmates in separate cases from November and December 2024.

- James Wright III, 42: Murder. The charge involves the June 2023 death of inmate James Harrison Pennington, who was Wright’s cellmate at Broad River CI at the time. Pennington was beaten to death in the cell.
- Roger Glenn Denver Rowland Jr., 35: Attempted murder, prisoner carrying a concealed weapon and possession of a weapon during a violent crime. The charges involve slitting a fellow inmate’s throat with a homemade weapon at Leiber CI.
- Jeremiah Charles Owings, 42: Robbery, stalking and five counts of violating a restraining order. The charges involve ordering an assault on a person in the community, stalking the person and using social media to reach out to people who have restraining orders against him. Owings was incarcerated at Kershaw CI.
- Demario Patrico Nesbit, 41: Trafficking methamphetamines and possession of contraband by a prisoner. The charges involve between 100-200 grams of meth found in his cell at Evans CI.
- Patrick Leshawn Brice, 51: Possession of narcotics with intent to distribute, possession of contraband by a prisoner and criminal conspiracy. The charges involve Suboxone strips sent to him at MacDougall CI disguised as legal mail.
- Joseph Calvin Creech, 53: Assault and battery second degree. The charge involves throwing boiling water on a correctional officer’s face at Broad River CI.
- Kyle David Hitchcock, 32: Assault and battery second degree. The charge involves hitting a correctional officer at McCormick CI in the face multiple times, which caused her to fall down a flight of stairs.
- Sean Jarrett Tomsha, 31: Assault and battery second degree. The charge involves an assault of his cellmate at Kirkland CI.

- Duwayne A. Fordham, 48: Throwing bodily fluids on a correctional officer. The charge involves throwing urine on an officer at Tyger River CI.
- James R. McCray, 31: Throwing bodily fluids on a correctional officer. The charge involves throwing feces at an officer at McCormick CI.
- Zion Rashaun Dukes, 23: Throwing bodily fluids on a correctional officer. The charge involves throwing feces on an officer at Lee CI.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in November and December 2024. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
