COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from January.

- Daniel Jermaine Reed, 26: Murder, attempted murder and two counts of possession of a weapon during a violent crime. The charges involve the October 2024 death of inmate Devin Javonne Wilson, a fellow inmate in the same housing unit at Lieber CI at the time. Reed is charged with stabbing Wilson to death with a homemade shank on the cellblock and also stabbing another inmate who was trying to stop the assault. That inmate was injured.
- Oscean Naqua Isai Goodlett, 29: Trafficking methamphetamines 100 grams or more and possession of contraband by a prisoner. The charges involve meth, an iPhone, charger, cable and headphones found in his cell at McCormick CI in August 2024.
- Ernest Thomas Singleton, 30: Assault and battery second degree. The charge involves an assault of his cellmate at Evans CI in January 2024.
- Donta Malik Dowe, 26: Assault and battery by mob second degree. The charge involves assaulting and threatening a fellow inmate at Trenton CI in June 2021.
- Travis Deneile Robinson, 35: Possession of cocaine with intent to distribute, possession of methamphetamines, possession of marijuana and possession of contraband by a prisoner. The charges involve cocaine, marijuana and meth found in his cell at Lee CI in July 2023.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in January 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
