**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for inmates in separate cases this week.

Four inmates were charged with assault and battery by mob second degree. The charge involves attacking a fellow inmate in the Wateree housing unit at Broad River CI on April 11. The inmate suffered a broken jaw, brain hemorrhage and collapsed lung. Those charged are:

- Darrell Cornelius Gleaton, 36,
- Lonnie William Smith, 42,
- David D. Stalk, 35,
- Greg Kelvin Isaac, 38.

Also charged in separate incidents are:

- Daquon Harrington, 29: Assault and battery first degree. The charge involves assaulting his cellmate at Broad River CI, who suffered life-threatening injuries including a traumatic head injury, collapsed lung and broken ribs.
- Barbaro Vazquez, 30: Assault and battery second degree. The charge involves stabbing a fellow inmate at Evans CI. The inmate suffered cuts and nerve damage to his arm.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in February 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
