**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a former inmate on charges involving contraband at Kershaw Correctional Institution.

Shaheim Tywaun Jackson, 26, of Columbia, is charged with trafficking methamphetamines and possession of contraband by a prisoner. The charges against Jackson involve more than 11 grams of meth found during a search while he was still incarcerated at Kershaw. Jackson's sentence ended, and he was released before SCDC received confirmation of the drug analysis. He was arrested today.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
