COLUMBIA, S.C. – The SCDC Inspector General released additional arrest warrants today for a former nurse assistant at Lee Correctional Institution.

Antoinette Briana Crawley, 33, of Greenwood, is charged with first-degree sexual misconduct with an inmate, providing contraband to an inmate and criminal conspiracy. The charges involve a sexual relationship with an inmate from August 2023 through October 2024, and providing the inmate with narcotics, SIM cards, TCH gummies and unapproved clothing items. She resigned in January before the investigation was complete.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
