**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from March.

- Xzariera Okevis Gray, 36: Murder, possession of a weapon during a violent crime and two counts of carrying a concealed weapon. The charges involve the September 2024 [death of Idris Wasim Ballard Gallardo](#), a fellow inmate in the same housing unit at Lee CI at the time. Gray is charged with stabbing Gallardo to death with a homemade shank in a common area of the housing unit.
- Ibn Gadson, 28: Assault and battery second degree. The charge involves striking a sergeant on the head with a lock and chain in July 2024 at Broad River CI. Gadson also is awaiting trial [on attempted murder charges](#) involving another assault on staff from June 2024.
- Kejuan Deangelo Dye, 31: Assault and battery second degree and carrying a concealed weapon. The charge involves an assault of his cellmate at Lee CI in June 2024.
- Donald Kent Harper Jr., 26: Throwing bodily fluids by a prisoner. The charge involves throwing feces/urine onto an SCDC employee at McCormick CI in January 2025.
- Rakeem Scott, 26: Throwing bodily fluids by a prisoner. The charges involve spitting in the face of an officer at Perry CI in January 2025.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in March 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
