COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a correctional officer at MacDougall Correctional Institution.

Jarrette Franklin Bryant, 44, of Vance, is charged with providing contraband to prisoners and misconduct in office. Charges against him involve bringing tobacco and a cellphone into the institution hidden in a potato chip canister. He was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
