COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrant today for an Orangeburg woman on charges related to an escape from a work-release site earlier this month.

Demetria-Micha Byrd, 29, is charged with aiding an inmate's escape from prison. The charge involves coordinating with inmate Ulysses Steven Conner Jr. after he walked away from his job at Bojangles in Florence on May 1. Social media accounts identify Byrd as Conner's wife.

Earlier this month, Conner's brother, Roland Leon Miley, also was charged with aiding an inmate's escape.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
