**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from April and May.

- Wyatt Xavier Woods, 54: Murder and possession of a weapon during a violent crime. The charges involve the May 2024 murder of Wood's cellmate Tristan Gist, who was stabbed to death in their cell at Lee Correctional Institution.
- Three inmates at Lee Correctional Institution are charged with seriously injuring an officer during an assault. Their charges are:
  - Romane Clare, 39, attempted murder and possession of a weapon during a violent crime.
  - Brody Lee Bridges, 35, assault and battery by mob second degree with serious bodily injury results.
  - Fabian Leonard Habersham, 34, assault and battery by mob second degree with serious bodily injury results.
- Three inmates at Broad River Correctional Institution are charged with assault and battery by mob second degree with serious bodily injury results. The case involved beating a fellow inmate inside a cell in the Wateree Dorm. Those inmates are:
  - Dequincy Christopher Howard, 31
  - Karras Cascelle Cohen Jr., 31
  - Robert Matthew Fulmer, 36
- Jarrett Nickolas Blanton, 32: Attempted murder. The charge involves repeatedly beating a fellow inmate on the face and head at Evans Correctional Institution in March 2024.
- Antuane Jamal Means II, 30: Attempted murder. The charge involves stabbing a fellow inmate on the face and back at Broad River Correctional Institution in October 2022.

- Tyrone J. King, 39: Assault and battery of a high and aggravated nature and possession of a weapon during a violent crime. The charges involve stabbing and beating his cellmate at Lee Correctional Institution.
- Rodney Sherard Edwards, 34: Assault and battery of a high and aggravated nature. The charge involves throwing hot liquid on the head of a fellow inmate at Evans Correctional Institution, which caused serious burns.
- Quincey Bernard Christian, 36: Assault and battery second degree. The charge involves beating a fellow inmate at Kirkland Correctional Institution.
- Fernando Javier Wright, 33: Disseminating obscene material to a minor. The charge involves sending obscene material to a person younger than age 12 from McCormick Correctional Institution.
- Dontravious Krenshaw Wise, 28: Throwing bodily fluids on an officer. The charge involves throwing feces onto an SCDC lieutenant at Lee Correctional Institution.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in April and May 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
