**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrant today for a licensed practical nurse who worked at Broad River Correctional Institution.

Stephanie A. Braun, 39, of Moncks Corner, is charged with second-degree sexual misconduct with an inmate. The charge involves having an ongoing sexual relationship with an inmate since March. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
