COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from June.

- Justin Jamal Lewis, 35: Four counts of threatening the life of a public official. The
 charges involve threatening to kill, rape and burn alive several SCDC staff members and
 their families. These offenses happened while Lewis was incarcerated at Lee
 Correctional Institution.
- Shemar Jaquan Dewitt, 23: Attempted murder. The charge involves stabbing a fellow inmate in his head, abdomen, shoulder and thumb, causing life-threatening injuries. The assault happened in a cell at Lee Correctional Institution.
- Two inmates at McCormick Correctional Institution are charged with assault and battery by mob second-degree. The case involves beating a fellow inmate. Those inmates are:
 - o Kevin Matthew Bowlin, 32.
 - o Tony Lamont Young, 32.
- Two inmates are charged with assault and battery of a high and aggravated nature. The
 case involves stabbing a fellow inmate with an ice pick, which caused serious injuries.
 The assault took place in a living area at Broad River Correctional Institution. Those
 inmates are:
 - o Timothy Albert Jenkins, 24.
 - Demichael Sheavon Razor, 30.
- Darrius Maurice Williams, 37: Possession of narcotics and possession of marijuana. The charge involves possessing the drugs at Kershaw Correctional Institution.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in June 2025. These are criminal

charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
