COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Summerville woman on charges involving contraband at Camille Graham Correctional Institution.

Asia Rivera Rodriquez, 42, is charged with furnishing contraband to a prisoner and criminal conspiracy. The charges against Rodriguez involve concealing contraband in her body and passing it to an inmate during weekend visitation.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
