**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from July.

- Emmanuel Shai Hutchinson, 44: Murder, carrying a concealed weapon by an inmate and possession of a weapon during a violent crime. The charges involve stabbing fellow inmate Terry Wayne Cook Jr. to death with a homemade wooden stake at Kershaw Correctional Institution on May 6. Cook died from his injuries June 5.
- Jeron Alondo Cook, 43: Two counts of kidnapping, assault and battery first degree, assault and battery second degree, possession of an illegal cellphone, possession of contraband by a prisoner and resisting arrest. The charges against him involve assaulting two officers and detaining them in his cell at Kershaw Correctional Institution in October 2024. The officers were trying to retrieve his contraband cellphone.
- Jujuan Jameal Council, 27: Assault and battery by mob second degree. The charge against him involves participating in an assault of a fellow inmate at McCormick Correctional Institution in August 2024.
- Ancel Ramon Harris, 31: Trafficking methamphetamines and three counts of criminal conspiracy. The charges against him involve working with a former correctional officer on a large-scale operation to introduce and distribute drugs and contraband at Broad River Correctional Institution in May and August 2024. The officer has pleaded guilty and awaits sentencing.
- Zeyvion Deshun King, 21: Assault and battery second degree. The charge against him involves stabbing a fellow inmate in the shower at Broad River Correctional Institution in April.
- Samuel M. Scott V., 38: Blackmail. The charge against him involves extorting money from the wife of a fellow inmate on a contraband cellphone while incarcerated at Kirkland and Kershaw correctional institutions beginning in October 2024.

- William Deguzman, 42: Assault and battery second degree. The charge against him involves throwing a hot liquid on a fellow inmate and burning him in their living unit at Evans Correctional Institution in September 2024.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in July 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

That on 10/10/2024 while at incarcerated at Kirkland Correctional Institution, located at 4344 Broad River Rd, Columbia, SC 29210 that one Samuel M Scott did commit the crime of Blackmail / Blackmail or Extortion.
