COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for two men on charges including trespassing or loitering and refusing to leave state correctional properties, criminal conspiracy and providing or attempting to furnish contraband to prisoners at Livesay Correctional Institution.

Wesley Nathan Finley, 36, is charged with trespassing and loitering or refusal to leave state correctional properties, criminal conspiracy and providing or attempting to provide contraband, tobacco, cell phones, lighters and chargers to an inmate. Jacob Leo Wright, 25, is charged with criminal conspiracy. Both are from Seneca, S.C.

Probable cause is based on police investigation and the defendant's own admission.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
