COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a former correctional officer, a former inmate and the former inmate’s brother on charges of operating a widespread operation to introduce drugs into SCDC prisons.

The charges involve sending books containing drug-laced sheets of paper to at least 20 inmates in 14 prisons. The drugs include suboxone and synthetic marijuana commonly known as K2. Agents confiscated 666 sheets of K2-soaked paper and 241 suboxone strips from packages sent from March-June. The packages all were mailed from the Woodruff Post Office.

“We fight daily schemes from criminals trying to bring contraband into our prisons, and I will not tolerate it,” SCDC Director Joel Anderson said. “These drugs are poisoning our inmates and are a danger to our staff. I am thankful we are holding these people accountable for the harmful situations they create.”

- Shataysha Quneeka Lewis, 36, of Woodruff, is charged with possession of suboxone with intent to distribute, possession of synthetic marijuana with intent to distribute, providing contraband to prisoners and criminal conspiracy. Lewis is a former correctional officer at Evans CI and left the agency in 2019.
- Devin Jamaal Kershaw, 41, of Chesnee, is charged with possession of suboxone, possession of a firearm by a felon, furnishing contraband to a prisoner and criminal conspiracy. Kershaw is a former SCDC inmate who served about 20 years for charges including kidnapping. He was released to community supervision in Spartanburg County in 2022.
- Coure Romaine Terry, 36, of Chesnee, is charged with possession of marijuana with intent to distribute.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.



Between March 11, 2025, and June 27, 2025, the Def, Shataysha Quneeka Lewis, did knowingly and unlawfully possess with intent to distribute a Schedule III controlled substance known as Buprenorphine and Naloxone, commonly known as Suboxone. The Def was found to be in possession of approximately 241 colored strips that contain Buprenorphine and Naloxone concealed inside books and packages for mailing. The Def utilized the Post Office located at 955 Main St, Woodruff, SC to send these packages. The intended recipients were 5 inmates located in 5 separate SCDC Institutions. Video surveillance footage shows the Def leaving her residence carrying packages consistent with the mailed contraband at the USPS Post Office in Woodruff clearly captures the Def mailing the suspicious packages. The pattern of packaging, method of concealment, and delivery to correctional institutions indicate clear intent to distribute. Warrant based on investigation. rap

Between March 11, 2025, and June 27, 2025, the Def, Shataysha Quneeka Lewis, did unlawfully possess with intent to distribute substance known as MDMB-4en-PINACA, a synthetic cannabinoid, a Schedule I controlled substance. The Def was in possession of approximately 666 small 2x3 inch sheets of paper which tested positive for MDMB-4en-PINACA. These K2-laced sheets were concealed within books, which were then mailed through the Post Office at 955 Main St, Woodruff, South Carolina. The Def used this method to introduce contraband and then distribute the substance to 15 inmates across 10 different South Carolina Correctional Institutions. Video surveillance footage captured the Def leaving her residence carrying the packages suspected to contain contraband to the Woodruff USPS Post Office confirms the Def mailing the packages. The pattern of concealment and targeted distribution to correctional facilities indicates clear intent to distribute the controlled substance. Warrant based on police
