**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from August:

- Marion Benjamin Powell, 39: Kidnapping, attempted murder, prisoner carrying a concealed weapon and possession of a weapon during a violent crime. The charges involve detaining and stabbing a fellow inmate at Ridgeland Correctional Institution on Sept. 23, 2024.
- Ulysses Steven Conner Jr., 33: Escape. The charge involves Conner's escape from a work-release detail in Florence County on May 1, 2025.
- Corey D. Geddie, 32: Two counts of third-degree assault and battery. The charges involve assaulting two officers at McCormick Correctional Institution on July 9, 2025.
- Natalia Chisolm, 42: Two counts of possession of illegal contraband drugs with intent to distribute, two counts of criminal conspiracy and possession of contraband by a prisoner. The charges involve drugs confiscated from Chisolm at Camille Graham Correctional Institution in March 2025, and drug transfers during weekend visitations in July 2025.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in August 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
