**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for two men charged with operating a contraband-filled drone at Kershaw Correctional Institution.

Pharrell Rashawn Dobson, 21, of Bluffton, and Jaheim Dobson, 19, of Varnville, are both charged with possession of marijuana with intent to distribute, providing contraband to prisoners and criminal conspiracy. The two were arrested near the prison after a drone carrying a package crashed onto the prison yard. The drone's controller was found in the car with the two men.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Copies of the arrest warrants are attached.
