COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a former contracted certified nursing assistant at Ridgeland Correctional Institution.

Fallon Ahmadreea Mixson, 25, of Norcross, Ga., is charged with first-degree sexual misconduct with an inmate and criminal conspiracy. The charges involve an ongoing sexual relationship with an inmate and conspiring to introduce contraband into the prison. She is no longer employed at the prison.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or between the dates of October 17, 2024 and November 14, 2024, one Fallon A. Mixson while employed as a Certified Nursing Assistant with the South Carolina Department of Corrections at Ridgeland Correctional Institution located within Jasper County, SC, did commit the offense of Criminal Conspiracy, when she willingly, knowingly, and unlawfully conspired with lawfully incarcerated South Carolina Department of Corrections inmate, [REDACTED] to introduce contraband items into Ridgeland Correctional Institution to include; loose tobacco, Marijuana, cigarettes, and unauthorized food items. Probable caused was based upon the OIG investigation which includes text communication between Mixson and said inmate discussing the packaging, concealment and introduction of the contraband items and a verbal statement from the inmate. This incident being in violation of the SC Code of Laws as amended.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or between the dates of October 17, 2024 and November 14, 2024, one Fallon A. Mixson while employed as a Certified Nursing Assistant with the South Carolina Department of Corrections at Ridgeland Correctional Institution located within Jasper County, SC, did commit the offense of Sexual Misconduct with an Inmate First Degree when she willingly engaged in sexual intercourse and sexual contact on multiple occasions with the victim; [REDACTED], a lawfully incarcerated inmate with the South Carolina Department of Corrections. Probable cause was based on the OIG investigation which includes digital evidence of the Mixson, and victim engaged in oral and vaginal intercourse obtained from a contraband cellular device belonging to the victim and a verbal statement from the victim. This incident being in violation of the SC Code of Laws as amended.
