**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a former contracted certified nursing assistant at Ridgeland Correctional Institution.

Fallon Ahmadreea Mixson, 25, of Norcross, Ga., is charged with first-degree sexual misconduct with an inmate and criminal conspiracy. The charges involve an ongoing sexual relationship with an inmate and conspiring to introduce contraband into the prison. She is no longer employed at the prison.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
