**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrant today for a staff member at Lee Correctional Institution for criminal conspiracy.

Sharon Elizabeth Smith, 36, of Sumter, is charged with conspiring to bring a set of custom jewelry teeth coverings, commonly referred to as grillz, to an inmate. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
