COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrant today for a worker in SCDC's Columbia food service warehouse.

Corina Richards-Parnell, 34, of Columbia, is charged with providing contraband to prisoners. The charge involves selling electronic cigarettes commonly known as vapes to three inmates. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
