COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for two workers at SCDC's Walden Farm in Columbia.

Corina Francine Richards-Parnell, 34, of Columbia, is charged with sexual misconduct with an inmate, two counts of criminal conspiracy, dissemination of obscenity and providing contraband to an inmate.

Brittany Alexandria Brazel, 35, of Elgin, is charged with accessory before and after the fact of sexual misconduct with an inmate, failure to report sexual misconduct, two counts of criminal conspiracy and two counts of providing contraband to an inmate.

The charges stem from <u>a September case</u> in which Richards-Parnell was charged with providing contraband to prisoners involving selling electronic cigarettes commonly known as vapes to three inmates.

The new charges involve a sexual relationship between Richards-Parnell and an inmate, with Brazel helping to make arrangements for meetings. The two also are accused of bringing contraband to the inmate. Both were fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
