COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a Spartanburg woman charged with mailing contraband to an inmate.

Kara Sue Alejandro, 31, is charged with possession of narcotics with intent to distribute and providing prisons with contraband. Her charges involve mailing a package containing 4,629 grams of tobacco and 40 Suboxone strips to an inmate at Tyger River Correctional Institution.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
