COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a correctional officer at Lieber Correctional Institution and a Sumter woman.

Kyle Daniel Quinn, 28, of Summerville, and Jamie Ingrid Brooks, 38, of Sumter, were both charged with providing contraband to prisoners, criminal conspiracy and bribing a public official. Quinn also was charged with misconduct in office.

The charges involve working with an inmate at Lieber CI to bring contraband into the prison from January to March 2025. Quinn was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
