COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from September-November:

- Bernard Huggins, 47: Two counts of attempted murder, possessing a weapon during a violent crime and inmate possessing an illegal cellphone. He is charged with violently stabbing two correctional officers on the head and neck with a shank at Evans CI on Aug. 7.
- Kelvin Lamar Dawkins, 42: Attempted murder. The charge involves an attack on a fellow inmate at Livesay CI on July 27.
- Ten inmates were charged with second-degree assault and battery by mob in a case in which an inmate was stabbed and beaten at Lee Correctional Institution on Feb. 6. The inmate victim sustained significant injuries. Those arrested are:
 - Tavis Andre Colston, 28.
 - Gerald Christopher Bryant Jr., 33.
 - Shemar Jaquan Dewitt, 24.
 - Windoff Tykeim Douglas, 25.
 - Johnquaviu Laquan Kelly, 22.

 - Nigel Catrell Thompson, 23.
 - Alvin Anderson, 30.
 - Nikeen Daundre Johnson, 32.
 - Michael Jamal Fowler, 33.
- Four inmates were charged with assault for actions taken during a fight with a homemade hatchet at McCormick CI on Aug. 19. Those arrested are:
 - James Eugene Creason, 25: Assault and battery of a high and aggravated nature and prisoner carrying a concealed weapon.

- Nathan Morgan, 32: Second-degree assault and battery by mob.
- Keith Everett Brown, 32: Third-degree assault and battery.
- Kevin Matthew Bowlin, 32: Second-degree assault and battery by mob.
- Three inmates were charged with attempted murder, second-degree assault and battery by mob, possessing a weapon during a violent crime and criminal conspiracy. The charges stem from a fight in which a fellow inmate was stabbed multiple times with a shank on Oct. 7, 2024.
 - Michael Jamal Fowler, 33.
 - Trevor Devon Morris, 25.
 - Nyquan Tykie Brown, 29.
- Two inmates at Broad River CI were charged with assaulting a fellow inmate with a shank and fists on Aug. 1.
 - Tamyajah Keandre Lindsay, 19: Second-degree assault and battery and prisoner carrying a concealed weapon.
 - Dakari Johnson, 18: Third-degree assault and battery. Johnson has since been released on parole while these charges are pending.
- David Justin Miller, 45: Second-degree assault and battery. The charge against him involves attacking and punching a fellow inmate at Kirkland CI on July 15.
- Keith Goins, 37: Possession of marijuana and other drugs with intent to distribute. The charge involves a contraband package passed during visitation on June 29.
- Jason Scott Morton, 41: Furnishing contraband to a prisoner and criminal conspiracy. The charges involve a contraband package at Livesay CI on July 29.
- Devan Johnson, 25: Two counts of threatening a public employee and prisoner carrying a concealed weapon. The charges involve an incident at Lee CI on Feb. 14.
- Kadidas Reaco Gossett, 25: Third-degree assault and battery and throwing bodily fluids on a correctional officer on July 21.
- Derrick Joseph Powell, 38: Three counts of throwing bodily fluids on correctional officers at McCormick CI on Aug. 11.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in September, October and November 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
