**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from December 2025:

- Joey Dean Coleman, 35: Making a bomb threat and six counts of threatening the life of a public official. The charges involve threats he made on Sept. 15 at McCormick CI.
- Five inmates were charged with assault and battery by mob second degree in a case in which an inmate was stabbed and beaten on Sept. 11 at Tyger River CI. Those charged are:
  - Freeman Anthony White, 22.
  - Darian Martavious Thomas, 28.
  - Demetrius Antwon Henry, 25.
  - Terry Shaimek Tyler, 23.
  - Zalen Debrantly Martin, 24.
- Two inmates were charged with assault and battery by mob second degree and prisoners carrying weapons. The charges involve assaulting a fellow inmate with a metal pipe and homemade hatchet on April 29 at McCormick CI. Those charged are:
  - Kenyari Swadarius Beatty, 31.
  - John Westly Hicks Jr., 33.
- Three inmates were charged with assault and battery by mob second degree in a case in which an inmate was beaten on Oct. 6 at Leath CI. Those charged are:
  - Ashley Marie Wiley, 32.
  - Mya Leann Groves, 24.
  - Shanya Joanna Higgins, 26.
- Lamont Wesley Cutner, 51: Second-degree assault and battery. The charge involves grabbing the victim's private parts over her clothes July 21 in an administrative proceeding at McCormick CI.

- Donta Kevon Reid, 33: Second-degree assault and battery. The charge involves grabbing the victim's private parts over her clothes June 30 in a living unit at McCormick CI.
- Chantiny M. Jeffcoat, 37: Throwing bodily fluids on a correctional officer. The charge involves spitting on an officer on Sept. 23 at Leath CI.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in December 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.


