**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for two employees at Turbeville Correctional Institution.

Latrese Victoria Rose Canteen, 46, of Florence and Latasha Moses Bostick, 42, of Lamar, were charged with various offenses.

Canteen, a certified nursing assistant, has been charged with:

- Financial transaction fraud greater than \$300 and less than \$20,000.
- Violation of the Computer Crime Act, value more than \$1,000 and up to \$10,000 second degree – first offense.
- Criminal conspiracy.
- Furnishing or attempting to furnish prisoners with contraband.

These offenses took place between July 2, 2024, and July 1, 2025.

Bostick, an administrative coordinator, has been charged with:

- Furnishing or attempting to furnish prisoners with contraband.
- Violations of the Computer Crime Act, value more than \$1,000 and up to \$10,000 second degree – first offense.
- Bribery of a public official.
- Financial transaction fraud greater than \$300 and less than \$20,000.
- Criminal conspiracy.

These offenses took place between Aug. 1, 2024, and Dec. 31, 2024.

Both Canteen and Bostick were fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

All in violation of 16-17-410 of the South Carolina Code of Laws, and such conduct involving public corruption and arising out of or in connection with a crime involving public corruption, and such conduct not having been authorized by law.


