COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a licensed practical nurse at Allendale Correctional Institution.

Allison D. Atkinson, 53, of Barnwell, is charged with nine counts of unlawful possession of prescription drugs. The charges involve taking drugs from the prison to her home. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
