COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from January 2026:

- Kenneth David Blackmon, 36: Escape. The charge involves walking away from a job site in Florence County Sept. 10, 2025, while he was incarcerated at Palmer Pre-Release Center.
- Corey Lamont Rutledge, 51: Two counts of providing contraband to prisoners and two counts of criminal conspiracy. The charges involve letters soaked in contraband disguised as legal mail at MacDougall CI in March and April, 2025.
- Cleayvon D. Rutledge, 37: Two counts of providing contraband to prisoners and two counts of criminal conspiracy. The charges involve letters soaked in contraband disguised as legal mail at MacDougall CI in March and April, 2025.
- Gregory Lee Hunter, 42: Providing contraband to prisoners, criminal conspiracy and bribery. The charges involve bribing an officer at Lieber CI to help smuggle contraband into the prison between January and March 2025.
- Robert Fuller, 35: Attempted murder and possession of a weapon during a violent crime. The charges involve threatening to kill a fellow inmate at Turbeville CI and stabbing him with a homemade weapon on May 23, 2024.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in December 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
