COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a correctional officer at Perry Correctional Institution.

Kimberly Ann Christopher, 42, of Iva, was charged with providing prisoners with contraband and misconduct in office. The charges involve moving money and contraband with inmates at Turbeville CI.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

From May 2024 through October 2025, the defendant Kimberly Ann Christopher, while employed as a Correctional Officer with Perry Correctional located in Greenville County, did knowingly and willfully furnish and attempt to furnish contraband to inmates, to wit: the defendant utilized Cash-app to transmit money to multiple inmates incarcerated at Turbeville Correctional Institution (TCI) at the request and direction of her husband, [Redacted] an inmate of SCDC housed at TCI. The defendant's actions constituted the furnishing of prohibited items to inmates and were done without lawful authority, in violation of South Carolina Code of Laws 24-03-0950.

From May 2024 through October 2025, the defendant, Kimberly Ann Christopher, while employed as a Perry Correctional located in Greenville SC, did knowingly, willfully, and unlawfully commit the offense of misconduct in office, in the defendant, while acting in her official capacity, utilized the Cash-App mobile payment application to transmit money to multiple inmates incarcerated at Turbeville Correctional Institution (TCI), at the request and direction of her husband, [Redacted] an inmate of SCDC housed at TCI. The defendant's actions constituted a willful and unlawful breach of the duties and responsibilities of her office as a Correctional Officer. This conduct is in violation of Section 17-25-0030 of South Carolina Code of Laws.
