COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for inmates in separate cases from February 2026:

- Trumaal Abdul Brown, 35: Murder, prisoner carrying a concealed weapon and possession of a weapon during a violent crime. The charges involve the stabbing death of inmate Mario Leven Harrison at Lee Correctional Institution Dec. 1.
- Four inmates were arrested on charges involving the stabbing and beating death of inmate Xavier Martez Delesline at Lee CI on Dec. 2:
 - Michael Jayvone Dennis, 28: First-degree assault and battery by mob with death results, prisoner carrying a concealed weapon and possession of a weapon during a violent crime.
 - Rickardo Davon Thompson, 34: First-degree assault and battery by mob with death results, prisoner carrying a concealed weapon and possession of a weapon during a violent crime.
 - Jarquez Kezavion Cooper, 28: First-degree assault and battery by mob with death results.
 - Cameron Christopher Williams, 30: First-degree assault and battery by mob with death results.
- Daniel Kaseon Miller, 24: Attempted murder, prisoner carrying a concealed weapon and possession of a weapon during a violent crime. The charges involve stabbing a fellow inmate multiple times, causing serious injuries at Turbeville CI on Jan. 2, 2025.
- Kendall Cohen, 23: Accessory after the fact of attempted murder and prisoner carrying a concealed weapon. The charges involve hiding a weapon that was used in an attack at Turbeville CI on Jan. 2, 2025.
- Justin Simpson, 40: Attempted murder. The charge involves stabbing a fellow inmate multiple times, causing serious injuries at Evans CI on March 6, 2025.

- Kameron Scott Horton, 25: Trafficking methamphetamines, possession of marijuana with intent to distribute, providing contraband to prisoners and criminal conspiracy. The charges involve a package of meth and marijuana dropped by drone on the prison yard at Turbeville CI on July 11.
- Temaka Lytonria Singletary, 34: Prisoner carrying a concealed weapon. The charge involves concealing a lock in a sock at Camille Graham CI on Dec. 4.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in December 2025. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
