COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for 12 inmates in separate cases from March 2026:

- Jonathon Coburn, 35: Attempted murder, possession of a weapon during a violent crime and possession of contraband. The charges involve the stabbing of a fellow inmate at Broad River Correctional Institution on Aug. 15.
- Curtis Tiwan Fowler, 42, and Bradon Lee Ashley Potter, 31: Second-degree assault and battery by mob. The charge involves the stabbing and beating of an inmate at McCormick CI on Dec. 3.
- Three inmates were charged with second-degree assault and battery by mob and criminal conspiracy involving beating a fellow inmate at Turbeville CI on Sept. 23, 2024:
 - Curtis Tiwan Fowler, 42.
 - Draevius Mingo, 23.
 - Faizon Syheen Speed, 24.
- Kendrick Nesbitt, 54: Assault and battery of a high and aggravated nature, possession of a weapon during a violent crime and prisoner carrying a concealed weapon. The charges involve stabbing a fellow inmate at McCormick CI on Jan. 12.
- Timothy Asantee McCain, 25: Second-degree assault and battery. The charge involves assaulting a fellow inmate at Tyger River CI on Nov. 15.
- Domonique Brown, 37: Second-degree assault and battery. The charge involves assaulting a fellow inmate at Ridgeland CI on Feb. 15-16.
- Jamarcus Deleon Foster, 37: Trafficking methamphetamines and providing contraband to prisoners. The charges involve possessing a package containing 90 grams of meth while incarcerated at Kershaw CI on Sept. 4.
- Marco Andre Clark, 43: Carrying a concealed weapon. The charge involves using a mop handle and extension cord during an assault at Broad River CI on Jan. 14.

- David Antonio Little Jr., 36: Second-degree arson and throwing bodily fluids on corrections officers. The charges involve setting an SCDC uniform and blanket on fire and squirting bodily fluids from a bottle onto a correctional officer at Turbeville CI on Oct. 22.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in March 2026. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
