COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a correctional officer at Trenton Correctional Institution.

Davisha Lasha Dent, 22, of Harlem, Georgia, was charged with providing prisoners with contraband, conspiracy to provide prisoners with contraband and misconduct in office.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
