COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for 16 inmates in separate cases from April 2026:

- Dabreon Charles Derrick, 27: Two counts of attempted murder, possession of a weapon during a violent crime and prisoner carrying a concealed weapon. The charges involve an assault on two staff members at Turbeville CI on Feb. 6.
- Six inmates were charged with second-degree assault and battery by mob and criminal conspiracy involving beating a fellow inmate at Broad River CI on Feb. 18:
 - Morris Hickson, 35.
 - Gerald Howell, 33.
 - Ryan D. Irby, 41.
 - Ernest Oneal Jenkins, 41.
 - Justin Marquise Pringle, 27.
 - Corey Niko Sanders, 33.
- Andrew Nicholas Martens, 24: Kidnapping and second-degree assault by mob. The charges involve an attack of a fellow inmate at Kirkland CI between Nov. 7-11.
- Javon Daquan Mack, 30: Second-degree assault and battery. The charge involves an assault on a fellow inmate at Broad River CI on Jan. 29.
- Jason Morris, 40: Second-degree assault and battery. The charge involves an assault on a fellow inmate at Palmer Pre-Release Center on Sept. 4.
- Bobby Gaylord Jenkins, 35: Furnishing contraband to a prisoner and criminal conspiracy. The charges involve introducing contraband at McCormick CI on Feb. 8.
- Corey Lee White, 34: Criminal Conspiracy. The charge involves conspiring to introduce contraband to Kershaw CI by drone on Dec. 20, 2024.
- Christopher Cortrell Clyburn, 43: Threatening a public official. The charge involves threats made to staff at Tyger River CI on Dec. 12.

- Curtis Stanton Medina, 33: Throwing bodily fluids on a correctional officer. The charge involves an incident at Lieber Ci on Oct. 12.
- Jody Lee Turner Jr., 31: Throwing bodily fluids on a correctional officer. The charge involves an incident at McCormick Ci on Feb. 1.
- William Latavion Mason, 26: Larceny. The charge involves stealing property from a fellow inmate at McCormick CI on Feb. 23.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in April 2026. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
