**COLUMBIA, S.C.** – The SCDC Inspector General released the arrest warrants today for a correctional officer at Manning Reentry/Work Release Center.

Allyssa Jasso, 29, of Columbia, was charged with nine different counts of bribery, misconduct in office and violating the computer crime act. The charges involve receiving \$2,500 on her cellphone in four separate payments from an inmate. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
