COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for 15 inmates in separate cases from May 2026:

- Jacob Coleman Barlow, 32: Bribery and money laundering. The charges involve transferring \$18,743 between May 2020-December 2021 to a correctional officer at Turbeville CI, where was incarcerated at the time.
- Kenyari Swadarius Beatty, 31: Two counts of third-degree assault and battery. The charges involve an assault on two officers at McCormick CI on March 4.
- Jerelle Hickson, 20, and Damerio Milek Jones, 25: Second-degree assault and battery by mob and criminal conspiracy. The charges involve an assault on a fellow inmate at Turbeville CI on Nov. 4.
- Michael Larone Williams, 37: Second-degree assault and battery by mob and criminal conspiracy. The charges involve an assault on a fellow inmate at Broad River CI on Feb. 18.
- Melvin Jerome Nelson Jr., 43, and Sean Mark Rodriguez, 41: Second-degree assault and battery by mob. The charge involves attacking a fellow inmate at Tyger River CI on Jan. 21.
- Jerry Scantling, 43: Second-degree assault and battery. The charge involves attacking a fellow inmate at Tyger River CI on March 1.
- Antonio Maurice Brown, 39: Violating a domestic violence restraining order. The charge involves contacting his victim 41 times on the telephone from Manning Reentry/Work Release Center from Nov. 11, 2025-March 31, 2026.
- Jason Veldeed Cox, 44: Violating a domestic violence restraining order. The charge involves contacting his victim 49 times on the telephone and twice by mail from Tyger River CI from Jan. 1-Feb. 9.

- Jamarcus Deleon Foster, 37: Trafficking cocaine, trafficking methamphetamines, possession of marijuana with intent to distribute and possession of contraband by a prisoner. The charges involve coordinating a package of drugs dropped onto the yard by a drone at Kershaw CI on Dec. 20, 2024.
- Dustin Lee Johnson, 35: Trafficking methamphetamines, possession of contraband by a prisoner, second-offense possession of a controlled substance and criminal conspiracy. The charges involve bringing drugs into Evans CI from an outside work detail on Aug. 9.
- Lee Grant Moody, 47: Possession of marijuana with intent to distribute, criminal conspiracy and possession of contraband by a prisoner. The charges involve contraband at Turbeville CI on April 12, 2025.
- Quashawn Markese Covington, 28: Possession of a cellphone by a prisoner and criminal conspiracy. The charges involve using an illegal cellphone to introduce contraband into Wateree River CI on Jan. 15.
- Marcus Antwan Greene, 38: Possession of a cellphone by a prisoner. The charge involves concealing two contraband cellphones inside a food container and book at McCormick CI on Sept 12.

When a currently incarcerated person is charged with a crime, the inmate still must be served with a warrant and be afforded a bond hearing. For scheduling purposes, this happens at SCDC once a month. These are cases that came up for bond hearings in May 2026. These are criminal charges in circuit court. They are different from disciplinary charges inmates might receive while incarcerated.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

Therefore, [REDACTED] did, by malfeasance, misfeasance, and nonfeasance, commit acts and omissions in breach of her duties as a sworn Law Enforcement Officer, including her duty of good faith, honesty, and accountability to the public as a result of the payment(s). All in violation of 08-13-705 of the South Carolina Code of Laws, and such conduct arising out of or in connection with a crime involving public corruption, and involving a violation of the South Carolina Ethics, Government Accountability, and Campaign Reform Act, and such conduct not having been authorized by law, against the peace and dignity of this State and contrary to the law in such case made and provided.

PROBABLE CAUSE:

That from on or about May 01, 2020, to on or about December 01, 2021, JACOB BARLOW did, in Clarendon County, while an inmate with the South Carolina Department of Corrections (SCDC), did conduct financial transactions totaling over **\$10,000** that he knew were the proceeds of, or were derived directly or indirectly from the proceeds of, unlawful activity. He conducted these transactions with the intent to promote the carrying on of unlawful activity. While knowing that the transactions were designed in whole or in part to conceal or disguise the nature, location, sources, ownership, or control of the proceeds of unlawful activity, to wit: Barlow exact, give, offer, assign, or agree to send U.S. currency via Cash App in the amount of **\$18,743.00** to or on behalf of [REDACTED], in return for influencing the discharge of her official responsibilities and failing to perform an act or act(s) in violation of her official duties. Therefore, [REDACTED] did, by malfeasance, misfeasance, and nonfeasance, commit acts and omissions in breach of her duties as a sworn Law Enforcement Officer, including her duty of good faith, honesty, and accountability to the public as a result of the payment(s). [REDACTED] conducted transactions over multiple accounts with BARLOW, who utilized multiple accounts and aliases with clear intent to convert, structure, transfer, or otherwise obscure the source of said funds to conduct otherwise illicit associations with inmates of SCDC. All in violation of 35-11-740 of the South Carolina Code of Laws, and such conduct involving a violation of the South Carolina Anti-Money Laundering Act, or a crime related to a violation of the Anti-Money Laundering Act, and such conduct also involving a crime involving computer crimes, or a conspiracy or solicitation to commit a crime involving computer crimes, and such conduct having not been authorized by law.

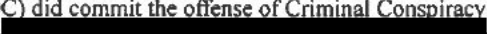

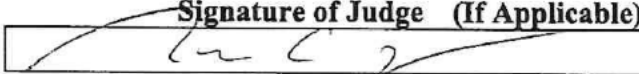
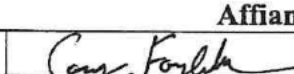
