COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for four former officers at Evans Correctional Institution.

- Edward F. Cain Jr., 34, of Pembroke, N.C.: Second-degree assault and battery by mob, criminal conspiracy and misconduct in office.
- Ja-Riek Takeem Richburg, 29, of Mullins: Second-degree assault and battery by mob, criminal conspiracy and misconduct in office.
- Hardy Jasper Sims IV, 49, of Latta: Second-degree assault and battery by mob, criminal conspiracy and misconduct in office.
- Addison Brinkley Waddell, 42, of Bennettsville: Criminal conspiracy and misconduct in office.

“These former employees violated the trust SCDC puts in its officers, and it is unacceptable,” SCDC Director Joel Anderson said. “Their behavior does not reflect the character of our officers or the values of our agency.”

The charges involve an assault on an inmate at Evans CI on July 24, 2025. Cain, Richburg and Sims are charged with assaulting the inmate in the prison’s restricted housing unit. All four are charged with conspiring to conceal the assault by attempting to alter medical documents. Cain, Richburg and Sims were fired in September 2025. Waddell was fired in October 2025.

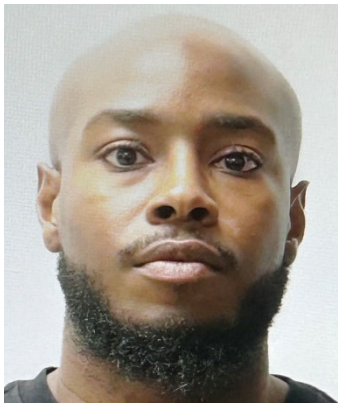
After the assault, the inmate was transferred to a different institution, where staff realized his injuries and took him to be treated at a local hospital.

The inmate had attacked a different officer earlier that day but was not injured during that incident. He was later convicted of an internal disciplinary charge of assault and battery with

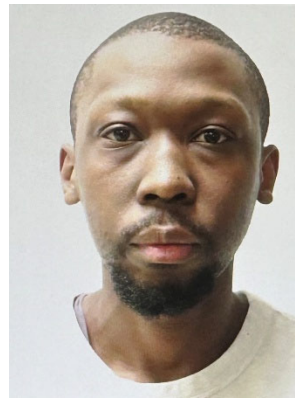
intent to kill for assaulting the officer. Criminal charges are being considered against the inmate in that case.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.

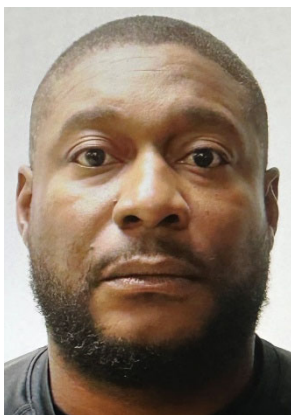

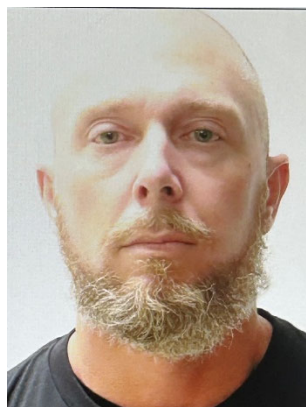
