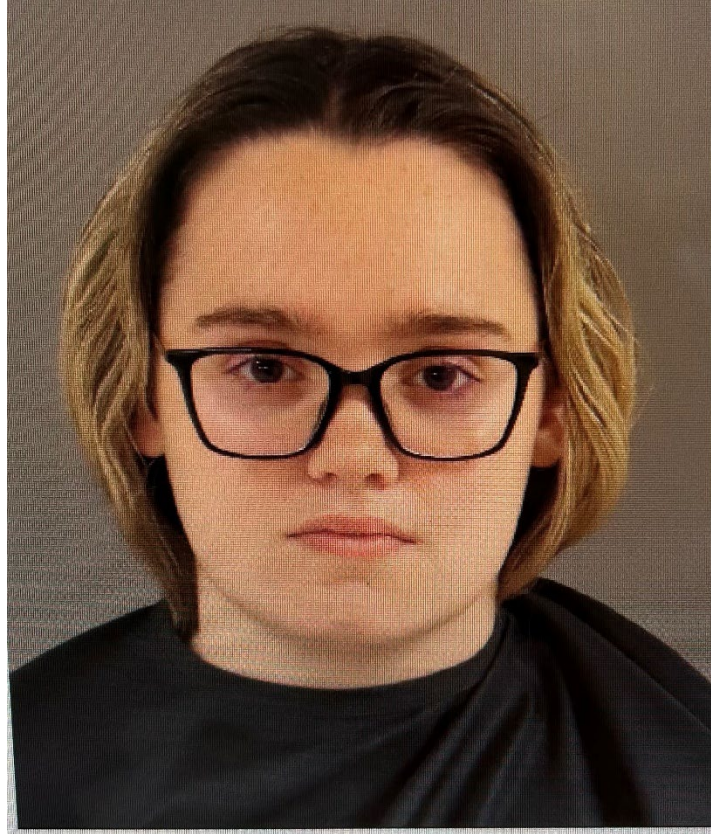

COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for a correctional officer at Wateree River Correctional Institution.

Jazmin Alexis Teas, 25, of Columbia, was charged with first-degree sexual misconduct with an inmate, criminal conspiracy and misconduct in office. The charges involve having a sexual relationship with an inmate and working with him to introduce contraband into the prison. She was fired.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
