COLUMBIA, S.C. – The SCDC Inspector General released the arrest warrants today for four people who threw contraband over the fence at MacDougall Correctional Institution.

- Justin Daniel Eaddy, 22, of Orangeburg.
- Antonio Brandon White, 36, of St. Matthews.
- Destiny Marie Langley, 27, of Sumter.
- Shimeisha Shadi Bell, 32, of Ehrhardt.

All are charged with providing contraband to prisoners and criminal conspiracy. The charges involve the group traveling to MacDougall and throwing contraband stuffed into Pringles potato chip cans over the prison fence. The packages contained tobacco, cellphones, cellphone chargers, rolling papers and lighters.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
