COLUMBIA, S.C. – The S.C. Department of Corrections Police Services released the arrest warrant today for former Correctional Officer Quitney Lavone Williams.

Williams, a former officer at Broad River Correctional Institution, is charged with Drugs / PWID Marijuana, Misconduct in Office, Criminal Conspiracy, and providing Contraband to an inmate.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
