**COLUMBIA, S.C.** – The S.C. Department of Corrections Police Services released the arrest warrant today for Marilyn Ann Williams, 47, of Florence.

Williams, a former lieutenant at Lee Correctional Institution, is charged with assault and battery third degree in a June 27 incident involving a coworker at the Bishopville prison.

The S.C. Department of Corrections reminds members of the public that after an arrest, the burden of proof is on the state to prove guilt beyond a reasonable doubt within a court of law.
